### **Back-To-School Preparation: Not Just About the School**

Use This Time to Revisit the Parts of Your Estate Plan That Impact Your Children Most

With all the considerations about your children's day-to-day activities, it can be easy to forget about one of the most important factors in keeping them secure: naming a guardian in your estate plan.

When was the last time you reflected on your selection of a guardian? If the answer is hard to pinpoint, it's probably time to revisit this issue. Children change a lot from year to year as they mature from infants into their teenage years. Their care needs and who would make a good guardian can change over time as well. Is the person you previously appointed as their guardian still the best choice?

Back-to-school time is a perfect reminder to revisit your estate plan and guardianship designations. Here are the specific areas to address:

- Review and refresh of guardianship nominations: Is the guardian you've chosen for your children still the person you would want to fill that role? Are they still available to do so, and would your children be satisfied with this choice of guardian?
- Review and refresh intent letters: If you've used intent letters in your estate plan to provide additional

meaning and context to your guardianship designations and other estate planning documents, it's a great time to make sure those reflect your current goals and wishes as well.

Review and refresh your estate plan: It's always a good idea to keep your estate plan as up to date as possible. The addition of a new child to your family by birth or adoption may mean your plan requires substantial changes. This is also the case if one of your children has turned 18. If either of these events occurred since our last assessment of your plan, it may be time to make alterations to your plan.

Back-to-school time means a flurry of activity for most parents. While shopping for supplies and attending school functions may dominate your to -do list, remember to meet with us to review your estate plan for any necessary updates that could impact your children. We're always here to help.

### Make an Estate Plan for Your Digital Assets

Every day, 77 percent of Americans go online, according to a recent Pew Research Center survey, and most of us maintain at least some kind of digital data in the cloud (whether or not we are aware of it). We save emails, post to social media, and store photos in online albums.

All of this digital information has created a new issue for you, your heirs, your beneficiaries, and the technology firms that hold your assets. The key concerns are maintaining your privacy and security and determining who can legally access this information upon your incapacity or death.



#### What's the concern?

Even though some digital assets and electronic communications have no monetary value, you may want some control over what happens to them when you die. Think about whether you want them deleted, modified, or distributed to family.

Some user agreements indicate that these assets are non-transferrable, meaning they are either untouchable or can simply be deleted when you die.

Beyond privacy issues, some digital assets and electronic communications do have value. Frequent flyer points are often transferrable after death, credit card points can be redeemed, and URLs may be saleable.

### What's your legal protection?

Under the law, your family members, executor, trustee or agent can't access such assets and communications just because of your relationship. Other users, including family members, need express authorization to access your accounts and information.

### How can you ensure your executor and/or family have access?

- Insert a provision in your living trust and/or will
  that grants your trustee and executor the authority
  to access digital assets and electronic
  communication accounts. If you want someone
  other than your trustee or executor to access such
  assets, you can appoint a special fiduciary for that
  specific purpose.
- 2. Add language that grants your agent under your power-of-attorney authority to act on your behalf during your lifetime (powers of attorney die with you).
- 3. It's a good idea to inventory your digital assets and provide your executor, trustee, and agent with the necessary passwords. Some online password managers can be set up to transfer passwords to a representative on your death.
- 4. Designate a digital "guardian" in any online tools that offer such a feature, such as Facebook's "legacy contact" and Google's "account trustee." This is someone who will look after your account after you've died. Be aware, however, that any such settings will override conflicting instructions you leave in your will or trust. If you want to prohibit disclosure, state that clearly in your estate planning documents.

Not only are our lives constantly changing, but the world around us is constantly changing too. The evolution of digital assets is a perfect example of that.
